Entry Rules

- 1. Entry is open to all youth CTF bowlers bowling in sanctioned youth leagues in BC.
- 2. Entry Fee paid on or before January 31, 2020: \$75 Lineage: \$49, Expenses: \$4, CYC Travel \$22, Entry Fee paid from February 1 to 24, 2020: \$85 Lineage: \$49, Expenses: \$4, CYC Travel \$32
- 3. Bowlers must have bowled in at least two-thirds of the league up to and including Febuary 24, 2020. League standings as of February 24th must be forwarded to the tournament manager.
- 4. All defending CTF Provincial Qualifying Tournament champions will be seeded directly to the Provincial finals at Splitsville provided the bowler has bowled two-thirds of the league schedule.
- 5. Education exemption: Any bowler who is unable to bowl in a CTF-Youth sanctioned league within B.C., due to education reasons, and who bowled in the most recent CTF Provincial Qualifying Tournament, will be entered into the provincial semi-finals. Such bowlers must be members in good standing of CTF and BCTF.
- 6. **Divisions for Scratch**: Age as of August 1, 2019 8 total divisions: 4 boys and 4 girls
 Bantam 11 and under Junior 12 through 14
 Intermediate 15 through 17 Senior 18 through 21
- 7. Bowlers may not enter the Provincial Qualifying Tournament if they have already attempted to qualify from another province.
- 8. No Refunds once entry fee is received.

Semi-Final Rules

- 1. This tournament will be sanctioned by CTF. **Seeded bowlers may not bowl in this event.** All CTF eligibility rules apply.
- 2. This is a singles tournament using scratch scores to determine team BC members.
- 3. Six games will be bowled on March 7, 2020 at Duncan Lanes and Splitsville 12:00 pm.
- 4. The top 5 finishers (plus ties) in each division will advance to the provincial finals at Splitsville on March 8, 2020.

 The following rules apply to both the Semi-Final and Provincial Final.
- 6. If a qualifier bowls in the wrong division, he/she will be disqualified.
- 7. Bowlers must wear suitable, clean and neat, attire throughout the tournament and awards presentation. Acceptable attire is limited to: Dress pants or jeans of appropriate size, dress shorts, skorts and capris, bowling shirts. Dress shorts/skirts/skorts must not exceed three-inches above the knee. Shirts must have sleeves, be able to be tucked in and have no obscene words or pictures. No bare midriffs. Clothing may not be ripped or cut. No hats. The tournament manager reserves the right to disqualify any bowler not wearing suitable attire after reasonable opportunity to change has been given.
- 8. Foul language or gestures will not be tolerated. Bowlers not abiding by this rule will be subject to disqualification with no refunds.
- 9. Tardy bowlers will receive zero for all frames missed.
- 10. No substitute will be permitted once competition has started.
- 11. <u>NEW:</u> Only Coaches that have completed Intro to Competition or Competition Development course and completed both Respect in Sport and Making Ethical Decisions will be allowed to be in the bowlers area. Only coaches that meet the requirements and officials will be allowed in the bowlers area.
- 12. Registrants authorize BCTF to take photographs at this event for purposes including, but not limited to; website media, newsletter publications and promotional use
- 13. Protests must be filed, in writing, within 30 minutes of the tournament completion.
- 14. The Tournament Manager will have full responsibility for appointing all tournament officials.
- 15. The use of flash cameras and any electronic device is not permitted during competition.

Provincial Finals Rules

- 1. This is a singles tournament using scratch scores (in eight divisions).
- 2. All divisions will bowl eight (8) games at Splitsville on March 8, 2020.
- 3. Each division will consist of the following (subject to eligibility):
 - a. Qualifiers from the Semi-Final
 - b. Defending Champions
- 4. One gold, silver, and bronze medal will be awarded in each division (twenty-four total).
- 5. In the event of a tie for any medal position, a one game roll-off will be conducted. Subsequent one game roll-offs will occur as required.
- 6. The eight provincial gold medalists will represent B.C. at the Canadian Tenpin Federation Youth Championships in Sault Ste Marie, Ontario May 28 to May 31, 2020. Travel days are May 29th and June 1st. (Subject to change). All members <u>MUST</u> participate in the training camp (April 2020). Failure to do so may result in the runner-up advancing.
- 7. Bowlers, coaches, and delegates will be required to pay their own expenses to the national championships (and any international championships, if applicable) if other funding is not available.
- 8. **NEW:** Each champion may be levied a \$500 charge to defray the cost of uniforms travel and tournament entry fee for the CYC's. Team members must sell 10 books of raffle tickets. Team members must have black dress pants for all official functions.
